## DIRECTIONS TO THE MEMORIAL HALL, TOWN HALL, RUGBY

### 1. By rail:

From Euston - Inter City trains are hourly

We would advise a taxi from Rugby station to the Benn Hall.

### 2. By road:

M-1: junction 20, join A-426 to Rugby and keep on A-426 until Newbold Road (at top of map) is negotiated. West Way car park is then on the right, off Corporation Street.

M-6: junction 1 - join A-426 to Rugby and follow instructions as above.

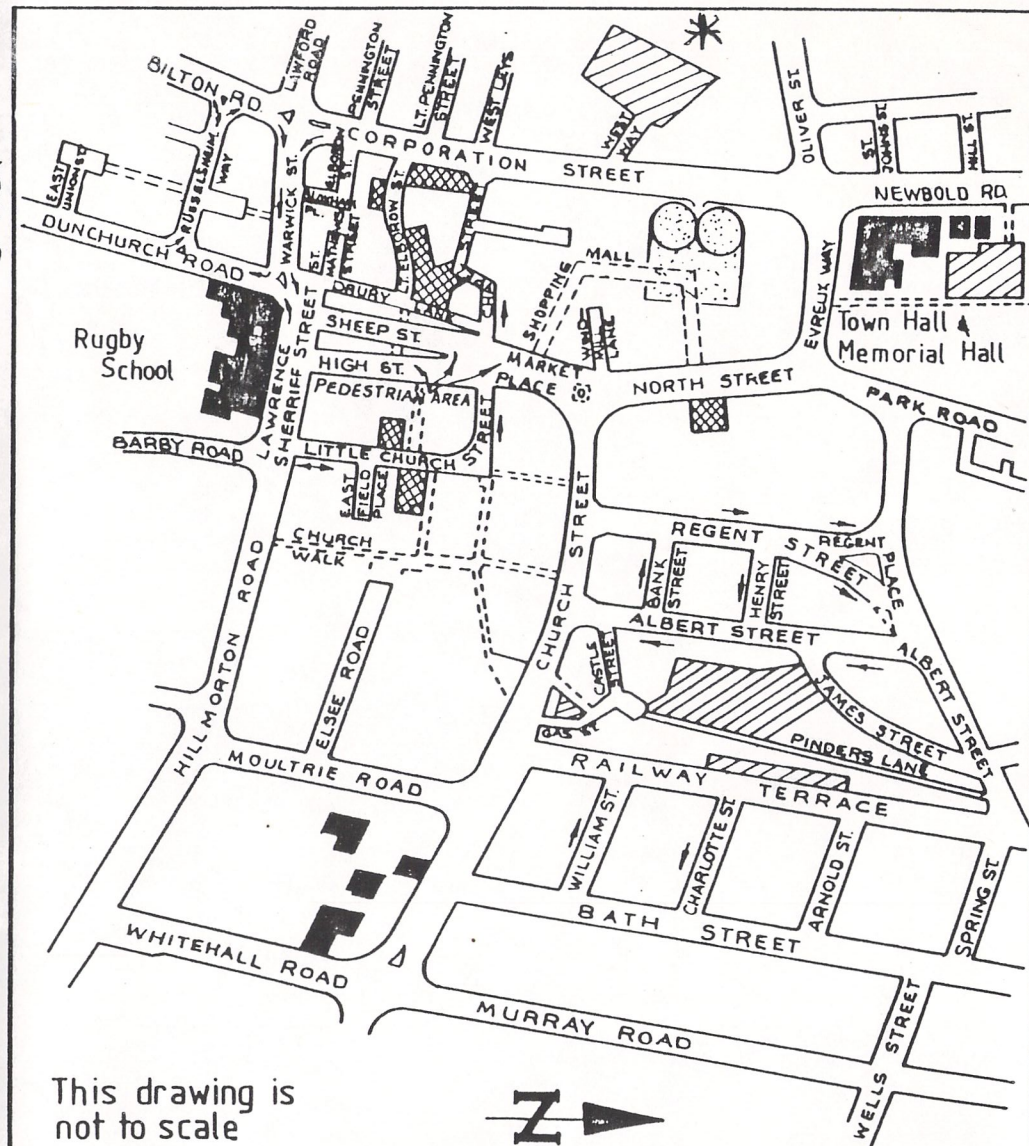
### 3. CAR PARKING
